Admission Notice for Admission into M.Tech. Programs under Sponsored (full-time)/part-time/Project staff/Institute Employee Categories during the Academic Session 2017-18

Applications in prescribed form are invited from eligible candidates under the above mentioned categories for admission to the M.Tech. Programs during the academic session 2017-18. Applications are to be sent directly to the respective Head of the Departments.

Last date of submission of the filled-in application form along with necessary documents to the respective Head of the Department, NIT SILCHAR, ASSAM 788 010, is 27 June 2017. Institute will not assume any responsibility for late receipt of application forms due to postal delay or other reasons. The filled-in application form must be accompanied with a nonrefundable processing fee of Rs. 500.00 for General /OBC and Rs. 250.00 for SC/ST candidates in the form of demand draft drawn in favour of THE DIRECTOR, NIT Silchar payable at SILCHAR. List of short listed candidates will be displayed in the Institute website/intimated by e-mail on or before 30 June 2017 by the concerned Head of the Department. Written test/Interview for selection will be held during 8-10 July 2017. No interim correspondence will be entertained.

II) **Minimum Educational Qualification:** Bachelor's degree in Engineering/Technology or equivalent in an appropriate area, with at least 60% marks or a CGPA/CPI of 6.5 on a 10 point scale. Relaxation of 5% marks or 0.5 in CGPA/CPI on a 10 point scale is applicable to the candidates belonging to SC/ST/PWD categories. A candidate with MCA (Master in Computer Application) degree may also apply for M.Tech. Program in the Computer Science & Engineering, subject to fulfilment of the aforementioned minimum educational qualification and other eligibility criteria.

In addition to the minimum educational requirement, candidates must also satisfy the other eligibility criteria as stipulated below.

III) Other Eligibility Criteria

1. A candidate seeking admission under the sponsored full-time category must be an employee of a recognised organisation and must have at least one year of working experience in the relevant field at the time of application. A sponsorship letter (Form-I) is required to be attached with the application form.
2. A candidate seeking admission under part-time category must be a regular employee of a recognised R & D organisation, national or any other recognized Institute, govt. organisation or industry and must have at least one year of working experience in the relevant field at the time of application. A no objection certificate (Form-II) is required to be attached at the time of application.
3. A candidate seeking admission under Project staff category must be an employee being attached with any on-going sponsored project in the institute. Duration of the project should be same as the duration of the programme. A no objection certificate from the project co-ordinator is required to be attached with the application form.
4. A candidate seeking admission under Institute Employee category must be an employee who has served the Institute continuously for a minimum period of two years at the time of admission. A sponsorship letter from the Director, NIT Silchar on recommendation of the concerned Head, is required to be attached with the application form.

IV) General Information:

- Minimum duration of the programme for full time sponsored category is two years, whereas for the other three remaining categories, the minimum duration of the programme is three years.
- Detection of any breach of trust, submission of any misleading document or concealment of information shall lead to termination from the Program at any stage during the course of study. In such a case fees already paid shall not be refundable.
- No financial assistance will be provided from the Institute.
- Applications not duly filled-in or not accompanied by necessary documents may be rejected.

The decision of the institute authority in all matters pertaining to admission is final.
