Pre-qualification criteria of the agency.

1.1 Contractor's registration :

Self attested up to date (renewed) contractor's registration certificate of appropriate class and category issued by the competent authority.

2.1 Up to date Electrical Contractor license (ECL) issued by the competent authority.

3.1 Up to date Electrical Supervisory license (ESL) issued by the Licensing authority, Govt. of Assam.

4.1 Work Experience:

Experience Certificate (EC) of at least one year in carrying out Annual rate Contract (ARC) of DG sets (500 KVA) operation job(s) under Govt./semi Govt. Department(s).Certificate is to be issued by an officer not below the rank of executive Engineer.

5.1 Average annual financial turnover:

Minimum year-wise Turn Over in rupees, during the last five years which should not be less than rupees ten lacs /year.

6.1 Financial solvency:

Financial solvency certificate issued by the scheduled Bank as per Performa given in technical bid document (Proforma-2C) for amount not below Rs.14.00 lacs during current financial year.

7.1 VAT registration:

Self attested copy of current /renewed VAT registration certificate (VRC)

8.1 EPF registration:

Self attested copy of EPF registration certificate along with current deposit challan for the year.

9.1 PAN No.:

Self attested copy of PAN card.

10.1 List of Team of Technical persons presently working under the contractor with their valid electrical license.

11.1 Application form & Declarations, as mentioned in the tender document.

Photocopy (duly self attested) of relevant document under Sl No. 1.1 to 11.1 to be enclosed along with Technical Bid document.

Tender document are to be submitted in 3 (three) separate envelopes. 1<sup>st</sup> envelop should contain Earnest Money ,2<sup>nd</sup> envelop should contain Pre-qualification (technical bid) duly filled up & signed along with relevant document as prescribed in pre-qualification criteria (PQC), and 3<sup>rd</sup> envelop containing price bid . **All 3 (three) envelopes are to be sealed in a single envelop, mentioning name of work, NIT no, closing date and time.** The 3<sup>rd</sup> envelop containing price bid will be opened only for those contractors who are found technically qualified as per condition of NIT.

Request for issue of tender document will be received up to 1.00 pm on **20.07.2016** and the tender document will be issued till **21.07.2016** up to 4.00 pm. The completed bid document is to be dropped in the Tender Box available at Estate Engineering Branch of the Institute up to 2.00 PM on **25.07.2016**. The envelop containing EMD, & technical bid in a sealed envelop will be opened on **25.07.2016** at 3.00 PM. The Price Bid of the successful agencies will be opened on **26.07.2016** at 3.00 PM.

Earnest money should be deposited in the shape of "Demand draft/FDR", issued by the scheduled Bank Guaranteed by the Reserve Bank of India, drawn /pledged in favour of "Director, National Institute of Technology, Silchar-10. The details may be seen in the Estate Engineering Branch of this Institute on any working day up to 4.00 pm.

Tender of any contractor not accompanied with proper earnest money and incomplete tender, non submission of requisite documents (Self attested) under Sl. 1.1 to 11.1 of the NIT or in any form shall be summarily rejected.
